Mobile Elevated Working Platform (MEWP) Training (1 day)

Mobile Elevated Work Platform training would be delivered to you on your own site; you would need to supply the machine/equipment and an area to conduct training. 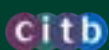
This course qualifies you to operate the specific type of MEWP for which you receive training. To operate a different type of MEWP requires a conversion course. To operate on any site in the UK with permission of the person responsible for the site H & S. It does not qualify you to instruct others in the use of MEWP or supervise anyone who has not received formal training and qualification in the use of MEWP.

Candidates Per Course

Maximum of 3 delegates per day. All Experiences.

Minimum PPE (Personal Protective Equipment)

- Safety Footwear** All delegates must wear safety footwear for the duration of practical training. Delegates will not be allowed to participate in training without safety footwear.
- Hi vis, hard hat** Must be available for the practical training and assessment.



Equipment requirements

The client is responsible for supplying all equipment & PPE.

Mobile Elevated Platform (MEWP)	In good, serviceable condition. Manufacturer's instructions should be made available for training.
Safety Harness	Boom Type MEWP's (Cherry Picker) Training. Two safety harnesses must be supplied for Cherry Picker training, one for a delegate and another for the instructor. Scissor Lift Training. A safety harness is not required for Scissor lift training to proceed but can be incorporated into training at the clients' request.
Practical training area	<p>For all vehicle-based operator/instructor training, a suitable manoeuvring area should be provided. As a rule of thumb, this area should be large enough that the vehicle used for training can comfortably perform a figure of 8 manoeuvre as a minimum.</p> <p>While training is in progress, access to this area should be restricted to the instructor and trainees. Where practicable, training areas should be sheltered from adverse weather conditions.</p>
Office/ Classroom/ Cabin	<p>A well-lit and suitable heated closed-door environment to conduct theory training. Tables and chairs to accommodate all delegates and the trainer assessor, this must include writing space for all delegates. A screen or projector is desirable but not essential.</p> <p>Exclusive use of this facility is required for between 60-120 minutes on the morning of each training day.</p>
