

It does not qualify you to instruct or supervise others who have not received formal training as a vehicle banksman.

# Minimum PPE (personal protective equipment)

Vehicle Banksman / Traffic Marshall



Safety	All delegates must wear safety footwear for the duration of practical
Footwear	training. Delegates will not be allowed to participate in training without safety footwear.
Hi vis coat, vest & hard hat	Must be available for the practical training and assessment.

## **Equipment requirements**

The vehicle should ideally reflect the type of vehicle that the Banksman will be banking. An Motor vehicle LGV/HGV or similar is preferable but not essential, a normal road car is sufficient for training. Certification will not be limited to the vehicle used during training. If desired, plant machinery such as Excavator, Dump Truck or similar can be used to complete training. **Practical** A suitable manoeuvring area should be provided; free from steep gradients and cannot be the public highway. This area should be large enough that the vehicle used for training area training can comfortably perform a simulated commercial reversing manoeuvre. While training is in progress, access to this area should be restricted to the instructor and trainees. Where practicable, training area should be sheltered from adverse weather conditions. Office/ A well-lit and suitably heated closed-door environment to conduct theory training. Tables Classroom/ and chairs to accommodate all learners and the trainer assessor, this must include Cabin writing space for all learners. A screen or projector is desirable but not essential. Exclusive use of this facility is required for between 60-120 minutes on the morning of each training day.
