Course duration is dependent upon delegate numbers and experience. There is no minimum number of delegates required for training to commence.

Novice	Less than 6 months operating experience 2 day course (1-3 delegates: 1 Instructor)
Experienced	More than 6 months regular operating experience 1 day course (1-3 delegates: 1 Instructor)
Refresher	Successfully completed formal training in the last 5 years 1 day course (1-3 delegates: 1 Instructor)

Lorry Loader (HIAB)

Equipment requirements

The client is responsible for supplying all equipment & PPE.

Lorry Loader Crane	In good serviceable condition. Manufacturers' instructions should be made available for training.
Loads/ Materials	A supply of realistic loads appropriate to the training being given. Training will simulate a working environment. Without a good selection of loads to handle, training might fall short of expected standards.
Lifting tackle	Sufficient that a load can be attached and lifted. Examples include Webbing Slings, Chain Slings, Round Slings, Wire Rope Slings, Shackles, Eye Bolts, Lifting Frames/Spreader Beams etc.
	All lifting tackle must have a current and in date certificate of inspection. This inspection should adhere to the Lifting Operations and Lifting Equipment Regulations 1998 (LOLER). The only exception being when training is completed using a grab attachment.
Practical Training area	While training is in progress, access to this area should be restricted to the instructor and trainees. Normal work tasks potentially may be incorporated at a later stage.
Office/ Classroom/ Cabin	A well-lit and suitable heated closed door environment to conduct theory training. Tables and chairs to accommodate all delegates and the trainer assessor, this must include writing space for all delegates. A screen or projector is desirable but not essential.
	Exclusive use of this facility is required for between 60-120 minutes on the morning of each training day.
